**INTRODUCTION:** Thank you for your interest in our club. We are a private member club with a 1000 membership cap. After our current members have a chance to renew their memberships, we will begin to absorb the remaining openings from our waiting list (between February-April).

**NRA MEMBERSHIP:** To belong to Aurora Gun Club, it is required to have a current NRA membership. *Motion # 07.10.01.c That as a condition of membership at the Aurora Gun Club starting in 2002, all club members must be members of the National Rifle Association. AMENDED 10.09.01.c Beginning in 2003.*


**HOW WE WILL CONTACT YOU:** You will be contacted by letter. All necessary information will be in that letter. **You will have 7 days to respond to that letter confirming your continued interest.** If there is no response, or if the address is not correct, no further contact will be attempted.

**ORIENTATION:** You will be required to attend an orientation which will go over policies, rules, and a range tour. There is a \$50 one-time orientation fee along with pro-rated dues through December.

**RATES:** Future Rates are as follows: \$150 per year (January-December), \$25 Bounce Check Charge, \$20 Spouse Card (orientation required), and \$1200 Lifetime AGC member. You will have 2 notifications – in November & December's newsletter. If you miss these, we will fill open memberships from the waiting list. There are opportunities to work off dues during work parties, senior discounts, and other discounts. You will stay informed as you read your newsletter each month.

**LATE FEES:** 04.10.07.a Motion: that the \$25 late fee be imposed on a member missing the Feb 1<sup>st</sup> deadline of the renewal period as long as the 1000 member cap has not been achieved. If the 1000 member cap is reached the member will be placed on the waiting list for membership the following year.

**EXPLANATION OF MEMBERSHIP:** Your membership will cover you, your spouse & dependent children (18 & younger) and one guest over 18 yrs. If you wish to purchase a spouse card for an additional \$20, this will enable him/her to shoot at the club individually. However, they must attend an orientation before receiving their card and they must be a spouse (not brother, adult child, girlfriend/boyfriend) living with you. They will not be able to bring any guests nor vote in the August Board of Director's election.

 **WAITING LIST:** If you would like a receipt, you may send a self-addressed, stamped envelope to the above address. A confirmation letter will be returned to you.

If, at any time, you wish to check the status of your place on the waiting list you may view it at the clubhouse, beginning in May. Thereafter, it will be updated monthly. ***There will be no phone verification, you must come in person.***
