#### III. MINUTES

**2.13.18 b.** Motion to approve minutes from January 9th meeting with correction noted:

Our YTD revenue is \$16,015 and our YTD expenses are \$15,118 leaving a net gain of \$897. Account balances: Checking Account \$142,556; Payroll Account \$3,364 and Savings Account \$788,158. Our assets with the JP Morgan Cash Holdings account is \$6,270. Our Fixed income account balance is \$124,830. Our Alternative Assets balance is \$122,420. Total JP Morgan is \$253,520.

<u>Maintenance</u> – AGC 2<sup>nd</sup> VP, Berry Patton – The kitchen in the clubhouse is almost done. He thanked the cleaning crew who cleaned up the clubhouse, as they did a great job. He received a bid from member, David Bonner, for a 6' extension on the overhang on the silhouette range.

<u>Board Openings</u> - AGC Board President, Tom Desmond, announced that the board had received emails from 2 members that had expressed interest in being on the board. He asked each of them to introduce themselves and tell the board a little bit about themselves.

We'll be starting up our 2018 Monthly Trap Shoots again in March and I would like to invite all AGC members to join fellow club members for some fun competition. The program consists of 50 Singles, 50 Handicap, and 25 pairs of doubles. You are free to shoot in all or some events as you choose. If you presently have a class for ATA or AGC, we will use those class rankings and yardages. If you don't have an established class or yardage, we will start you in Singles and Doubles as a "B" class shooter. For handicap, we will start ladies at 19 yards and men at 20 yards. As you win your event class, you will earn yardage and move up in class. Normal member trap fees apply and, as we have done in the past, there will also be the option of playing for some class pots for Singles and Doubles as well as our Progressive Pot for Handicap. The Progressive Pot pays 70% of the current Pot total if you are successful in running all 50 handicap targets!

The 2018 dates scheduled so far are as follows: March 11, April 8, May 13, June 3, July 15, August 12, September 16 and (tentatively) October 14. Registration begins when the clubhouse opens and shooting will begin shortly after we start squadding. Please note that the shoot is open to AGC members as well as family members, but pot options are only available to registered AGC members (so if Dad or Mom is the primary member, kids can shoot, but not play the prize pots). For those members who have participated in our program in the past, than you very much for your past support and I look forward to seeing you again in the new season. For new members and members who have not shot the programs in the past, please come out and join in for these fun events - we would like to increase club turnout. Whether you're an avid trap shooter or someone who occasionally likes to bust a bird or target, this is a good event to hone some of those shooting skills.
