Pete Benoit – Pete asked the board for approval to host a couple of training classes in the education trailer, possibly at the end of March or early April. The classes will be RSVP only for up to 14 people per restrictions and masks are required. He will email Nicole the dates/times.

Dietrich Whitesides – The NRA Action Pistol group will not be holding their match on February 13<sup>th</sup> due to weather and would like to do a makeup match on February 27<sup>th</sup>. This was approved.

Loren Kohler – Loren requested \$150 to run the annual full-page ad about the clubs ATA matches in the Colorado State Trapshooting Association's 2021 Colorado State Shoot Program publication. He is also going to register his matches for PreSquad.com and increase his match fees from \$28 to \$30.

#### V. OLD BUSINESS

<u>Financial Report</u> — Treasurer, Loren Kohler - January: Account balances: Checking Account \$55,781; Payroll Account \$10,659 and Chase Savings Account \$272,978; Bank of the West Money market account \$152,194; Edward Jones CD – closed. Bank of the West CD \$206,059; Chase Bank CD \$201,831. Loren will provide two reports for January and February 2021 next month. There was a delay due to the switching accounting firms. Loren provided a breakdown of the tax report to the board. He received a request from a member to see the final income statement, which he will provide to the member. Loren also had a member volunteer to perform the 2020 financial review which is tentatively scheduled for April 17th.

<u>Maintenance Update</u> – 2<sup>nd</sup> VP of Maintenance, David Faingold – The excavation work on the creek is complete and they did a great job. Dietrich asked how often we should clear the creek and David recommended every 10 years. Tom asked how much the excavation work costs the club. The cost was \$5,600. In addition to the excavation work, David also asked the company to trim along the back side of the berms. David asked Richard to replace the deck on the rifle shooter's building which he will do with Trex decking materials. Tom mentioned that support beams will need to be closer together if using Trex decking materials.

Review COVID-19 Restrictions – President, Tom Desmond – No change to the club restrictions. Arapahoe County moved from orange to yellow. Chris mentioned that he and Richard measured the ed building and can safely fit 15 people for new member orientations which is 50% occupancy. Tom asked Nicole to include an announcement in the newsletter about maintaining social distancing of 6 feet in the clubhouse and masks are required.

#### Attention AGC Members - COVID-19 Modified Restrictions

The board appreciates your patience during the State-wide Safer-at-home order with the following restrictions.

The following limitations, until lifted by the board, supersede the related published AGC rules:

- Remember if you feel sick, stay home.
- The club is open to members and guests (maximum of four guests at one time per the standard rules). Please be sure to continue to follow all rules associated with "Guests" per the Aurora Gun Club Member Rules.
  - Member badges must continue to be visible at all times.
