BOARD MEETING MINUTES 7/13/2021

Meeting called to order at 7pm by President Tom Desmond

Present: Boyd, Desmond, Baker, Kohler, Caraway, Whitesides, Quiring and Faingold

Excused Absence – Dobbs, Proxy goes to Loren Kohler.

I. CALL TO ORDER

IV. MEMBERS FORUM

Chris Baker - Dave Leiker asked Chris if we should delay the BBQ until the clubhouse is complete. Board discussed and decided to leave the BBQ as scheduled on Saturday, July 31st.

V. OLD BUSINESS

Financial Report — Treasurer, Loren Kohler - June revenues were \$19,787 and our expenses were \$24,655 leaving a net loss of (\$4,868). Our YTD revenue is \$106,003 and our YTD expenses are \$143,743 leaving a loss of (\$37,740). Account balances: Checking Account \$46,250; Payroll Account \$8,552 and Chase Savings Account \$115,996; Bank of the West Money market account \$152,614; Edward Jones CD – closed. Bank of the West CD \$206,161; Chase Bank CD \$201,898. Loren said the CD is coming due and rates are not good.

Maintenance Update – 2nd VP of Maintenance, David Faingold – David received an email from a member asking about rebuilding the bridges on the 100 yd range after they were washed out from the recent rains. David first checked with the Southeast Metro Storm Water Authority (SEMSWA). SEMSWA is the governing authority of the Flood Plain in which AGC property sits. SEMSWA's concerns are that the flow of water is not impeded by anything. Any projects would involve SEMSWA and their fees. David was then referred to ICON engineering which has worked with AGC previously. ICON emailed David some bridge options that have been approved by SEMSWA previously. That letter had been forwarded to the board. The matter was discussed, and the bridge washout was thought to be a random seasonal event. There was no need to spend the money as the foot bridges have been successfully put back into place. Chris Baker asked about the Education building and how the south side of it needs repair. David suggested siding and will look into price.

Clubhouse Renovation Status – Board Member, Mel Caraway – Mel asked the contractor to give a report at the board meeting, but he was unable to attend. The contractor told Mel that he is waiting for the electrical engineer permit and working with the other engineer on overall building plans. Framing will commence this week. Monday of last week the contractor also told Mel he still needs some additional information to proceed and offered to contact Loren to get the information about Excel usage. The club will need to provide a years' worth of Excel bills to calculate consumption to see if it is worth replacing the HVAC. Michael will get the bills from the files he has to scan and send to the contractor. Loren will also get the remaining Excel bills he has as well to scan and send to the contractor as well.

Summer BBQ Status – Board Members, Manny Boyd/Michael Quiring – Michael received the final quote from Hickory House. The food for BBQ is a total of \$3,484.66 including setup, serving and clean up. Dessert will be purchased from Sam's Club. He also received three tent/table quotes from two vendors. First option is for a 40 x 70 tent which stakes into the asphalt, 20 tables and 200 chairs, second quote is

for a 40 x 70 tent with water barrel hold downs, 20 tables and 200 chairs and third quote is for 5 - 20 x 20 tents, 20 tables and 200 chairs. Tom asked Michael to get an updated quote cutting the second option in half with 10 tables, 100 chairs and smaller tent to accommodate the tables.

VI. NEW BUSINESS

Incident Report – President, Tom Desmond – No official reports.

Rules Committee Meeting — President, Tom Desmond – The rules committee meeting will take place on Saturday, August 14th at 9:00am.

Investment Opportunities — Treasurer, Loren Kohler – Loren received a proposal from Bank of the West on how to invest our CD's into an investment vehicle that would provide a better rate of return than the current CD rates. The investment goal would be to outpace inflation. That is the current CD rate is 0.01% and if inflation is 3%, we lose 2.99% of our value. Ideally the investment goal is to be greater than or equal to the inflation rate. He is asking to form an investment committee to review this and other options. The committee will be volunteer members. Any member with investment experience is asked to participate. Nicole will add an announcement to the newsletter.

Purchasing New Furniture for Clubhouse – Board Member, Mel Caraway – Mel discussed with the board about getting new furniture for the clubhouse which would include folding chairs and tables. The folding chairs are half the cost and easier to store. He said the tables we have are older, but we could possibly salvage some of them and only purchase a few new ones. Chris would like to see about moving some of the better tables to the ed building classroom. One of the tables Mel looking into are \$275/table. Tom wants to get furniture that will last long term. Mel will also look at getting waste containers and asked the contractor if he could possible build something.

Review August Calendar – Nicole Quiring reviewed the August calendar.

X. ROUND TABLE

Dietrich Whitesides – Dietrich asked why we did not put up a shade on berm 2. There used to be a tree there, but it was removed because it was dead.

Mel Caraway – Mel asked about the sound barrier on the 100 yd range. He would like to angle the barrier between the end of the building but not impede the tractor area. Sound bounces inside the cover outside the clubhouse and ear protection is required when waiting to shoot trap. Loren suggested waiting until next year when wood is not so expensive and suggested building a small redwood wall.

Michael Quiring – Michael asked how the ladies' shoot went. David Faingold read a thank you note he received from member, Anne Draper to the board and indicated that the shoot went very well.

Loren Kohler – Loren mentioned that this weekend is the zone qualifier for the ATA shooters. Loren also asked about the credit card machines from the clubhouse and how they could be used in the ed building right now. Discussion was had about how to setup the credit card machine in the ed building. Michael and Tom will look at various options.

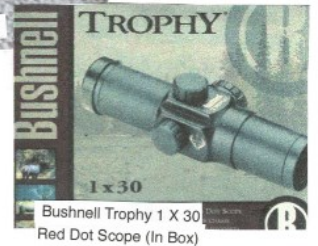

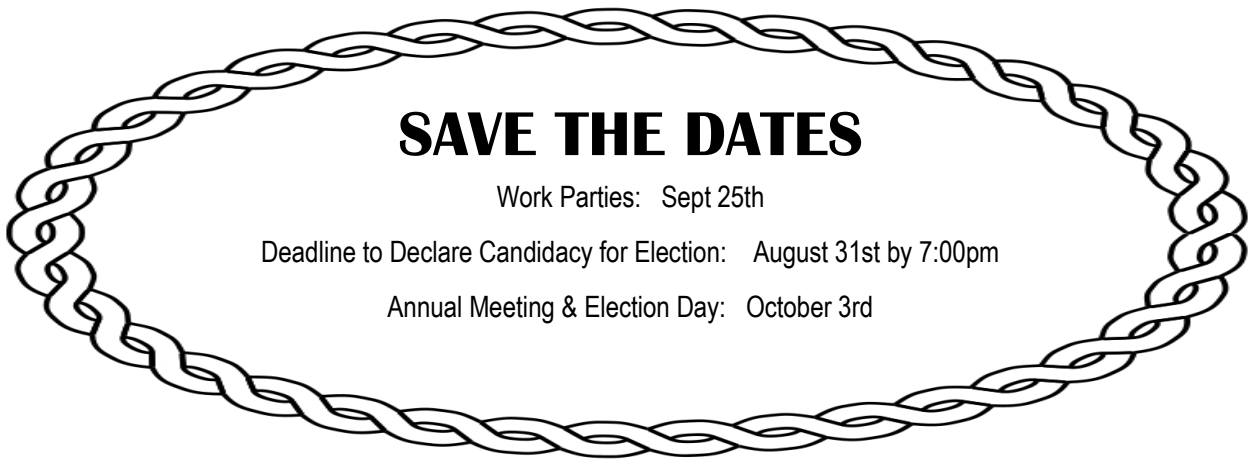
