BOARD MEETING MINUTES 8/11/2020

Meeting called to order at 7pm by President Tom Desmond

Present: Baker, Boyd, Desmond, Faingold, Kohler, Leiker, Quiring, Whitesides, Caraway

I. CALL TO ORDER

Motion seconded and passed

VII. MEMBERS FORUM

Randy Still – Randy asked if the club can get a golf cart for the Range Officers to drive around the club to check on things. He said it had been discussed at a previous meeting a few years ago and wanted to bring it up again. Randy stated that he could get a good used one at a reasonable price. Tom said that he would need to check with the insurance company to see if getting a golf cart will affect the insurance rates.

Loren Kohler – ATA Match - Loren mentioned there is a service called PreSquad.com he would like to look at for ATA events. PreSquad.com is subscription based and he will do a cost analysis and get back to the board. In his analysis, he will contact other local gun clubs to see how they pay for the subscription fees. Do they absorb them or pass the cost along to shooters?

Chris Baker – Muzzleloader - Chris asked the club for \$100 plus tax to purchase plaques for his event.

8.11.2020 c. Motion to approve \$100 to purchase plaques for Black Powder discipline matches

Motion seconded and passed

Tom Desmond – One of the trap shooters suggested that the club discontinue using paper cards for trap and just pay with coins (\$5.00) all the time. There would be an exception for Wednesday trap as the price difference is \$4 on Wednesdays. Don runs the match on Wednesday and would like to keep it as is. The coins would be attached to the clipboards instead of cards. The paper cards will continue to be used until they are all gone, and the clubhouse would no longer sell new paper cards, just coins. David Faingold mention that the coin operated system is a success and says he would like to add another coin machine at some point. The discussion will be added to the September agenda.

Tom Desmond – Dave Bonner sent an email asking for \$350 for trophies for his NRA Silhouette Match.

8.11.2020 d. Motion to approve \$350 for Dave Bonner's request to purchase trophies for the NRA Silhouette Match

Motion seconded and passed 7 to 2 – Board members, Deitrich Whitesides and Loren Kohler did not approve.

VIII. OLD BUSINESS

Financial Report— Treasurer, Loren Kohler - July revenues were \$21,822 and our expenses were \$31,340 leaving a loss of (\$9,518). Our YTD revenue is \$147,089 and our YTD expenses are \$163,783 leaving a loss of (\$16,694). Account balances: Checking Account \$56,979; Payroll Account \$10,675 and Chase Savings Account \$198,959; Bank of the West Money market account \$151,956; Edward Jones CD – closed. Bank of the West CD \$205,877; Chase Bank CD \$201,742. Looking at expenses, as utilities were up significantly from last July. Received another copy for bankruptcy protection from the Oil Company that was going to drill. Does not look like they will be doing anything more.

Maintenance Update – 2nd VP of Maintenance, David Faingold – The asphalt company came out a second time in August to perform warranty work on the areas that still had standing water near the caretaker's house. He believes the issue was addressed and it is good now. The trees were removed on berm 6. He also purchased 6 new trees from the Tree farm to replace those that died. David will work on replacing the rock in the trap area with smaller pea gravel for safety purposes. Michael suggested pavers instead of rock but that may be too costly. There is a piece of the top of the 100-yd cover that is warped. David will call the company that installed the cover to see if they can address the issue.

September Work Party - 2nd VP of Maintenance, David Faingold – The next Work Party is scheduled for Saturday, September 12th at 8:00am. The club will be closed that day. Members that attend will need to practice outdoor social distancing and should plan to bring masks as well as provide their own beverages and snacks for the day.

Rules Committee – Review of Proposed Rules - 1st VP of Membership, Chris Baker – The Rules Committee met at the club on Saturday, August 1st. The committee consisted of Chris Baker, Michael Quiring and Mel Caraway. Discussion of proposed rules. ~~Strikethrough is removal~~ and underlined is added. Unquoted plain text is additional background on the proposed change. The following changes were proposed:

GENERAL RULES ALL RANGES

A9. ~~The use~~ Possession of alcoholic beverages is not permitted on AGC Property. Anyone under the influence of drugs or alcohol, or suspected of the same may not handle a firearm and will be required to leave the AGC property.

TARETS

~~T2. Use of proper/appropriate steel targets on the 100 yard range, the 50 yard ranges, or the Silhouette range must be positioned so all projectiles fired will impact near the middle of the berm or be driven down into the dirt.~~

T3. All shotgun patterning must be accomplished on the patterning board located in berm 1. Patterning paper is available in the clubhouse when open. (Moved to B6)

~~T4. Steel targets are prohibited on 50 yard berms #1 and #7. (Moved to B5)~~

~~T5. Only personal targets may be used for crossbow bolts or broad head arrows on the archery range. (Moved to AR1)~~

GUESTS

GU1. All guests must sign in to include family members. During open clubhouse hours sign in shall be at the clubhouse. When the clubhouse is closed, sign in shall be at the caretaker drop box using provided envelopes. All guests must sign the club liability waiver. Parents of minor children must sign the waiver for their children. **(Moved GU5 to GU1 and shifted GU1, GU2, GU3 and GU4 down)**

50 YARD RANGES

~~B3. No centerfire rifle cartridges in berms 1 and 7 to include .223, 5.56, and 7.62 X 39. Pistol caliber cartridges and shotgun shells are the only ammunition permitted on berms 1 and 7.~~

~~B4. Firearms will not be handled for any reason when someone is forward of said firearm. Eg: If a member and/or accompanied guest is firing a weapon at the 15 yard line and weapons are on a table at the 45 yard line the latter may not be handled.~~

~~B5. The use of steel targets are prohibited on berms 1 and 7.~~

~~B6. All shotgun patterning must be accomplished on the patterning board located in berm 1. Patterning paper is available in the clubhouse when open.~~

100 YARD RANGES

~~C7. All rounds fired must impact near the middle of the berm. Proper Steel targets should be placed as close to the back of the berm as practical.~~

200 YARD RANGES

~~D3. TARGETS: Steel targets on the 200 yard range must be positioned to the far right side of the impact berm so all rounds fired impact safely. Only lead bullets are allowed for 200 yard steel targets. Jacketed bullets are prohibited for 200 yard steel targets.~~

~~D4. All other Paper targets must be positioned in the center of the target frame backer, no hanging or mounting of targets to the frames structure. Removal of targets is required prior to leaving the range.~~

ARCHERY RANGE

~~AR1. Only personal targets may be used for crossbow bolts or broad-head arrows on the archery range.~~

~~AR2. No handling of firearms within the boundaries of the archery range.~~

SILHOUETTE RANGE

~~ME4. During CMP matches, shooters may shoot in front of the benches on the 200 yard range.~~

8.11.2020 e. Motion to accept the updated Member Rule changes as documented and discussed.

Motion seconded and pass

Clubhouse Improvements Update – Dave Leiker – There were two companies that came out to look at updating the clubhouse. One of the companies said they could not perform the work right now due to a few big projects that came up. The second company would not be able to give an exact bid until they had a definitive job/plan in place for the clubhouse improvements. One of the improvements that was talked about during the meetings was the flooring and it was suggested that maybe an epoxy coating could be put on the floor and that would take about a week to do. The next step would be to get an architect (maybe a member) to work on plans that can be given to a contractor for an exact bid. Chris Baker suggested waiting until Jan/Feb 2021 to do any work to the clubhouse, during a slower time of the year. Deitrich contacted three companies and only heard back from one. Michael may have someone in mind that could give a bid.

Employee Range Use - 1st VP of Membership, Chris Baker – Chris would like to make a change on page 14 of AGC Employee Manual. The change would include adding a new section that references that an employee's use of the range is contingent upon attending a new member orientation.

8.11.2020 f. Motion to accept the update to the Employee Manual to include an employee's use of the range is contingent upon attending a new member orientation.

Motion seconded and passed

Review COVID-19 Restrictions – President, Tom Desmond – No updates at this time. Manny mentioned that the sports store by Southlands and Water World were offering testing.

IX. NEW BUSINESS

Incident Report – President, Tom Desmond - No official reports. However, it was mentioned that a member fell off a bench at the 200-yd range and broke his hip. He was there for the military match when he fell. He was taken to the hospital by ambulance. It was discussed that the 3-legged benches need to be fixed so they are sturdier for members. David Faingold said this can be added to the list of things to do at the Work Party on 9/12.

BOD Election Ballot Initiative – President, Tom Desmond – Tom received an email from a member asking about the required NRA membership for AGC members. Tom looked at the club bylaws and they were updated in 2002 to include that AGC members would be required to hold an NRA membership to be a member of the club. The election results for this change included a 290 member vote which was only 29% and while the current requirement for a bylaw change is 40% member approval, Tom has not been able to verify the requirement from the old bylaws. After some discussion by the Board, it was determined that there is no real benefit for the club to require that members hold an NRA membership and there could be other second amendment agencies that could also be a consideration. Tom would like to add a ballot initiative to this year's ballot to include removing the NRA membership requirement. The club would need approximately 415 members to vote for this change to updated in the bylaws. Deitrich will check on the affiliation between the NRA and the club. This topic will be added to next month's agenda.

BOD Election Update – Election Chair, Dave Carriker – The election is still possible for this year as we have 3 candidates and only need one more for an election to take place. August 25th is the deadline for members to send in their candidacy. A mass email notification will be sent out to members.

Review of September Calendar – Nicole Quiring reviewed the September Calendar.

X. ROUND TABLE

Manny Boyd – Manny mentioned that the tire at number 16 on the 100-yd range still need to be repaired.

Loren Kohler – Loren had a member volunteer to help with the annual finance review on Saturday, August 15th in the education trailer.

Chris Baker – Chris will be hunting next month and might miss the September board meeting. He asked for someone to take his proxy if this happens. Loren Kohler offered to take Chris' proxy if necessary.

Dave Leiker – Dave has noticed that people drive through the parking lot too fast and would like to ask about getting a flashing speed limit sign. Tom mentioned that the club has looked into it before and the signs are around \$1,000. We could possibly look at getting speed bumps instead.

Carla mentioned that speed bumps in the parking lot could present a real barrier to snow plowing. David Faingold will look into possibly adding speed bumps. Also, he asked if the 100-yd target stands were going to get worked on. They will check with Willie when he is back at the club.

Loren Kohler – Called the club phone and it went directly to voice mail. Wanted to know if the phone could ring in the clubhouse first.

Attention AGC Members - COVID-19 Modified Restrictions

The board appreciates your patience during the State-wide Safer-at-home order with the following restrictions.

The following limitations, until lifted by the board, supersede the related published AGC rules:

- Remember – if you feel sick, stay home.
- The club is open to members and guests (*maximum of four guests at one time per the standard rules*). Please be sure to continue to follow all rules associated with “Guests” per the Aurora Gun Club Member Rules.
 - Member badges must continue to be visible at all times.
- The clubhouse, the education trailer and the bench rest trailer are now open, however they are limited to 10 persons in the building, “social distancing” must be maintained, no food or beverage preparation and a contact-tracing record is required if people are closer than 6 feet for more than 15 minutes. All persons 11 years and older are required to wear face masks when inside all club buildings.
- Trap:
 - Shooters must maintain 6 feet distance from each other at all times.
 - “Regular” weekend trap, Wednesday trap and clubhouse operations resumed in June
 - Coin operated use Mondays, Tuesdays, Thursdays, and Fridays.
 - Coins may be purchased in the clubhouse on Saturdays and Sundays
- Discipline shoots will be limited to 25 participants (or 25 per berm) with contact tracing.
- Spacing on flagged ranges must maintain 6 foot social distancing.
- Berm use is limited to 25 persons per berm and must maintain 6 foot social distancing.

***Please note: Monthly Board Meetings will have limited seating, due to the requirements for social distancing.
