V. ELECTION RESULTS – Dave Carriker announced that the results have not changed since the 10/4/20 Annual Meeting. Board of Directors elected include David Faingold, Michael Quiring and Ron Dobbs. Carl Schuldies came in 4th. The ballot measure failed and there is no change and what is posted to the board, the clubhouse door and stat building are the same. Tom thanked Dave Leiker for all he has done at the club and time he served on the board. Dave in turn said it was a pleasure to serve on the board.

VI. APPOINTMENT OF EXECUTIVE BOARD – Tom said that members elect the board and the board decides the positions they hold. Manny said he would like to make a motion to approve the board positions as they are now, if no one objects. No objections were made. Tom Desmond – President, Chris Baker – 1st VP Membership, David Faingold – 2nd VP Maintenance, Michael Quiring – Secretary, Loren Kohler – Treasurer, Emmanuel Boyd – Board Member, Dietrich Whitesides – Board Member, Mel Caraway – Board Member, and Rob Dobbs – Board Member. 10.13.2020 e. VII. MEMBERS FORUM

David Faingold – David received feedback from member, Phil Mortenson and he recommended that on the AGC website calendar to include the ability to click on the discipline event date and more detailed information would be listed such as contact information for the chairman, duration, appropriate firearm and ammo. A discussion was had about updating the information that is currently listed on the website for the individual discipline pages to include that information. Tom also suggested doing an email alias for those that did not want to list their personal email on the website.

Dave Lieker – Dave asked two more companies to give us an estimate on updating the clubhouse. One company did not respond, and the other has not looked at it yet. Dave will give an update as it is available.

Dave Bonner – Dave has his receipts for the pins and trophies for his discipline. He is requesting the full reimbursement of \$149. The amount a discipline can be reimbursed for trophies is \$100. Dave asked for an exception because the information that was listed in March newsletter from the February meeting minutes was \$150 and he was going off that information. Chris Baker mentioned that he thinks the board should look at the amount the board reimburses as that amount has been in place for many years and things cost more now. Tom asked if Dave had a copy of the check he used to pay for the items that shows the exact amount that was paid, and also said Dave would be reimbursed once a check was submitted. Dave Bonner asked how decisions regarding the Committee Chair discounts were made. He was told that participation plays a part in the decision. Dave explained that he had not been attending matches because of COVID-19 but had been working behind the scenes to help the discipline be successful. The board agreed to give Dave his committee chair credit for the year.

Dietrich Whitesides - Dietrich asked on behalf of Bob Daneker, NRA Action Pistol chairman, if the club truck could be used for the NRA Action Pistol

Pistol registered match and setup day on 10/23 & 10/24. The match will take place on berms 1 - 4 those days. Tom said Richard and the trap assistants are on the insurance to drive the truck and he would just need copy of the driver's license to be added to the insurance.

VIII. OLD BUSINESS

<u>Financial Report</u> — Treasurer, Loren Kohler - September revenues were \$19,546 and our expenses were \$36,169 leaving a net loss of (\$16,623). Our YTD revenue is \$188,702 and our YTD expenses are \$221,164 leaving a loss of (\$32,462). Account balances: Checking Account \$53,555; Payroll Account \$12,041 and Chase Savings Account \$167,965; Bank of the West Money market account \$152,062; Edward Jones CD – closed. Bank of the West CD \$205,929; Chase Bank CD \$201,742. Discussion was had about expenses.

Maintenance Update – 2nd VP of Maintenance, David Faingold – David did not have a lot to report this month. He discussed what the club can do to help with erosion control to the berms by adding a clay type soil to the existing areas. He also said he would like to give the club's business to Land Tech instead of using Town and Country. Land Tech is a bigger and better company to service our needs. He got a bid from Land Tech to handle the goat heads and weed mitigation. Loren received a new agreement from Town and Country and asked David if he would like to contact them. David will contact Town and Country to inform them of the club's decision to change vendors. David received a request to add work party credit hours for a member from the April work party and it has already been 6-8 months from that date. Work party credit hours need to be submitted in a timely fashion for processing. Add an announcement to the newsletter that any work party credit hours must be coordinated with David Faingold before the work is done.

Review COVID-19 Restrictions – President, Tom Desmond – No changes.

IX. NEW BUSINESS

Incident Report – President, Tom Desmond – No official reports.

Discuss 2021 Calendar Dates – President, Tom Desmond – Anne Draper submitted an updated Event Request Form and has asked for the Ladies Shoot to take place on Saturday, June 26th. Dietrich mentioned that the NRA Action Pistol group would like to have 3 - 4 more registered shoots in 2021. Nicole will work with Dietrich and Anne to determine if that date will work and not overlap with the NRA Action Pistol registered match. Work Party dates were determined for 2021 and will take place on Saturday, April 24 and Saturday, September 25. The club will not host a Christmas party in 2021 but instead have a summer BBQ on Saturday, July 31st. Manny said to take caution and not be in a hurry to have a Christmas party too soon due to COVID. Add an announcement to the newsletter that the club will have a summer BBQ in place of a Christmas party in 2021. The Swap Meet will be on Saturday, June 5th and Election day will be on Sunday, October 3rd.

<u>Discuss Stale Receipts</u> – Treasurer, Loren Kohler – Loren has in his possession 6 receipts for reimbursement that are dated between August – October 2019 and one from May 2020. He would like to bring to the shooting chairman's attention that the receipts need to be submitted in a timely fashion and must be turned in within 90 days. The club will create a new policy that would require shooting chairmen to submit their receipts for reimbursement within 90 days of the purchase. The policy will go into effect 1/1/21.

10.13.2020 f. Motion to institute a 90 day policy for discipline chairmen that have expenses that need to be reimbursed must be submitted to the Treasurer (treasurer@auroragunclub.com) or President (president@auroragunclub.com) within 90 days of the expense. If they are not submitted within 90 days they will not be reimbursed.

Motion seconded and passed

Review of November Calendar - Nicole Quiring reviewed the November Calendar. Calendar approved.

III. INTRODUCTION OF BOARD CANDIDATES - AGC President, T. Desmond - Changed to Dave Carriker

Dave Carriker – Today is our Annual Election day. Ballots are being handled now, polling will close at 1pm and counting will happen as soon as possible. Record number of mail-in ballots at 336, box has 50 ballots so far.

Dietrich Whitesides – Deitrich asked if we would hit the 40% to eliminate the NRA requirement. Tom said it was not looking that way because it requires 40% of the membership to vote yes and so far we have received ballots for less than 40% of the total membership. A member (unknown) in attendance asked if there was a discussion about pros and cons. Tom said that the pros are that we don't think we get anything from the NRA today. Tom also mentioned that a member raised this up, not the board and the member raised it up before the most recent NRA scandal made the news. The cons are that the NRA fights for the 2nd Amendment and by not supporting them we don't have the 500-pound gorilla backing our constitutional rights. Tom also assured the members present that the board raised this as a ballot initiative to allow the members to vote and decide but the board did not lobby for either side and remained neutral. Tom then stated the board questioned the vote in 2002 to add the NRA requirement because it would not meet the requirements of the bylaws in 2020 but we are unable to locate a copy of the bylaws from that time period.

Candidates in attendance briefly spoke:

Dave Faingold – I am currently acting in the role of VP maintenance. I hope you like what I've done.

Michael Quiring – I have been on board for the last 3 years and looking forward to 3 more.

Ron Dobbs - Not in attendance

Carl Schuldies - Not in attendance

IV. RECESS UNTIL ELECTION COUNTING IS COMPLETE

V. ELECTION RESULTS - Meeting resumed shortly after 1:00 pm. Dave Carriker announced the results of the Election. 1st Place David Faingold with 304 votes – 2nd Place Michael Quiring with 297 votes and 3rd Place to Ron Dobbs with 268 votes. We had a record number of ballots of 388 and no in-valid ballots this year.

Attention AGC Members - COVID-19 Modified Restrictions

The board appreciates your patience during the State-wide Safer-at-home order with the following restrictions.

The following limitations, until lifted by the board, supersede the related published AGC rules:

Aurora Gun Club 2020/2021 .22 Rimfire Sporter CMP Match (non-sanctioned)

Aurora Gun Club will be holding 60-round (+ 5 minute unlimited sighters) CMP .22 Rimfire Sporter Matches on <u>SATURDAY</u>, November 14, December 12, January 9 and February 13. (Second Saturday of the month) Sign-in starts at 09:00, shooting begins at 09:30 on the 100 yard rifle range. Match fees are \$5 for AGC Members and \$10 for non-members (this covers range fees and targets).

These matches are "non-sanctioned" (scores will not be reported to the CMP), but the match will be run in accordance with the CMP rules (we won't be sticklers on the rifles used, but match standings will be based on those using rifles that conform to the CMP rules). If you have any questions about the rules, please go to www.odcmp.com/comm/rimfire.pdf.

Match consists of 5-minute unlimited sighting shots followed by 10 rounds prone slow and 2 rapid fire strings of 5 rounds in 25 seconds for semi-autos, 30 for bolt guns at 50 yds. Then repeat the sequence in seated position and Offhand. Offhand is at 25 yds. New shooters are welcome and encouraged.

Finally --- we will remain optimistic with regard to weather. However, if the temperature is below 40 F or if there is or has been precipitation at 09:00 on the day of the match, the match will be cancelled.

Action Pistol won out and right away I could see that I made the right choice! They'll be plenty of time to chase ducks, geese, pheasants and rabbits but only a few more Action Pistol matches before the end of the year.

Consistency is one of the best characteristics of the action pistol crowd. From the scores we shoot to who is first at the gate to who sets up targets or runs the timer, you know who is going to do what. About the only thing better than crowd-consistency is when new shooters show up!

Last month we welcomed Brian O'Boyle and Mark Eakin. If you remember I mentioned the skill level of Brian. Well, this month he posted our high score, a 481-15X (out of a 420-42X) on the Los Alamitos. And that's the way it's done! Good job Brian. Steve Knoll was up to his old tricks and shot well today.

A lot of us shoot .22 rim fires just because they are fun. The only problem is that you are plagued by many malfunctions. Scott Stewart's .22 gave up the ghost and quit working. No big deal, it can be fixed. But the cool part is that Scott used my .22 (also a S&W Victory with the same sights and a few other "modifications") to finish the match. It looked to me like he may have shot some personal best today. A good gun will do that for you!

Today we offered a 5th stage—the Los Alamitos. This added another possible 420-42X to the scores. Director Bob thought that since we were out there anyway why not get a little more shooting in.
